**6<sup>th</sup> ANNUAL MIDWEST PALMA® CHAMPIONSHIP**

**DATE:** June 21, 2005 – Palma® 4-Man Team Match or Individual Practise (fired concurrently)(close 7:30 am)(starts 8:00)  
June 22,23,24, 2005 – Palma Individual Matches (entries close 7:00 am)(starts 7:30 am)

**LOCATION:** The Winnequah Gun Club Range, approximately three miles north of Lodi, WI. Take I-90/94 to the LODI-ARLINGTON turnoff (Exit 119) about 25 miles north of Madison, and turn west on WI HWY 60 toward Lodi (3 miles). Just before Lodi, turn north (right) on Lindsay Rd. and proceed to CTY HWY J (0.7 miles). Continue north on J to the CTY HWY V (1.2 miles) intersection, turn west (left) on CTY HWY V to Lang Road (0.3 miles), turn right. Distance from Interstate Highway is approximately four miles. Camping is permitted and the gate will be open by noon on June 20 for those who wish to stay overnight.

**RULES:** Current NRA High Power Rifle and NRA Long Range Classification rules will apply. Empty chamber indicators (Rule 3.21) will be available at the range and **MUST** be used by all competitors.

**SAFETY:** For the safety of the pit crew, a competitor who fails to get on target in **TEN SHOTS** may be directed to stop firing. For purposes of this rule, an oblong hole from a ricochet does NOT count as a hit. **All sighting shots must be scored on back of score card!**

**ELIGIBILITY:** Open to any member of the NRA. Juniors may be a member of an NRA affiliated Junior Rifle Club. Teams will consist of four members.

**EQUIPMENT:**

- Individual Matches: Palma® rifle - Rule 3.3.3. Sights: Metallic only – Rule 3.7(a).
- Individual Matches: Service rifle – Rule 3.1, 3.1.1, 3.1.2, 3.1.3 (includes .223 Rem).
- 1,000 yd Matches: Any rifle iron sight - Rule 3.2.
- 1,000 yd Matches: Palma® rifle – Any sight
- 1,000 yd Matches: Any rifle – Rule 3.2. Sights: Any sight – Rule 3.7(c)
- Palma® 4-Man Team Match: Palma® rifle – Rule 3.3.3. Sights: Metallic sight – Rule 3.7(a).
- “F” Class – competitors may use sand bag or bipod rests (from the ground), no bench rests allowed. Any rifle, caliber .34 or smaller (no muzzle brakes allowed) may be used. There are no restrictions on sights.
- AROS – any rifle, optics, sling: separate category from “F” class; **NO** sandbags, other rests or muzzle brakes allowed.

**ENTRIES:** Individual entries will be made by using the enclosed entry form accompanied by a check or money order. Be sure to indicate your correct NRA Long Range classification, NRA membership number and email address. Unclassified competitors will compete in the Master Class. Rule 19.6-Assigned Classification, or 19.2-Temporary Classification, may be used in making entry. **IF YOU ARE NOT CHECKED IN AT THE STAT OFFICE 30 MINUTES BEFORE FIRING TIME, YOUR SPOT WILL BE GIVEN TO A PERSON ON THE WAITING LIST.** Mail individual entry form with correct fees to:

Individual match entries for all three days have priority and will be accepted up to capacity of the range (66) until June 19. Confirmations will be sent by email. Any entries received after June 19 will be considered late entries and charged a late entry fee. **If you cannot attend the match, please notify me immediately.**

**SQUADDING:** All matches will be squadded. Individual scorecard packets will be available for pick up at the Stat Office after 4:00 pm on Tuesday, June 21. NRA Long Range classification and membership cards must be shown before squadding is issued. A competitor who fails to present himself/herself at the proper firing point when his/her relay is called may lose his/her right to compete in that event. Squadding for the Team Match will be drawn by the Team Captain when registration is completed.

**COURSE OF FIRE:** (Long Range targets will be used at 800, 900, 1000 yards.)(competitors will score and pull targets)

**Tuesday, June 21 – 8:00 am**

Palma® 4-Man Team Match and Individual Practise will start at the 800 yard line.

Match 1: Palma® 4-Man Team, 15 shots each firing member at 800, 900, 1,000 yds  
Unlimited sighters at 800 yds; 2 sighters at 900 and 1,000 yds; two 47 minute time periods/match

**Wednesday, June 22 – 7:30 am**

Match 2: Palma® Individual, 15 shots each at 800, 900, 1,000 yds; 22 minutes each match  
Unlimited sighters at 800 yds; 2 sighters at 900 and 1,000 yds

Match 3: 1,000 yd Individual, 20 shots, Any Rifle, Iron Sight; 30 minutes; unlimited sighters

**Thursday, June 23 – 7:30 am**

Match 4: Palma® Individual, 15 shots each at 800, 900, 1,000 yds; 22 minutes each match  
Unlimited sighters at 800 yds; 2 sighters at 900 and 1,000 yds

Match 5: 1,000 yd Individual, 20 shots, Any Rifle Any Sight; 30 minutes; unlimited sighters

**Friday, June 24 – 7:30 am**

Match 6: Palma® Individual, 15 shots each at 800, 900, 1000 yds; 22 minutes each match  
Unlimited sighters at 800 yds; 2 sighters at 900 and 1,000 yds

Match 7: 1,000 yd Individual, 20 shots, Palma® Rifle, Any Sight; 30 minutes; unlimited sighters

Match 8: Palma® Aggregate only (Matches 2, 4, 6)

Match 9: 1,000 yd Aggregate only (Matches 3, 5, 7)

Match 10: Midwest Palma® Match Championship Aggregate (Matches 8, 9)

**MATCH CANCELLATIONS:** All efforts will be made to complete the matches. If one day's matches are cancelled, a refund of \$30 will be made to the squadded competitors in that match.

**AWARDS:** 50% of the individual entry fees will be returned to the competitors in cash awards. Awards will be given if there are 5, 10, 15 or more competitors in a given match or class. If there are fewer than five individuals or three teams in a class, they will be combined with the next class, except for High Masters. Lower classes will not be combined with the High Master class.

**"F" CLASS COMPETITORS:** All individual events are open to participation by F-Class competitors. F-Class competitors will compete only among themselves and ARE NOT eligible for Overall or Class awards in the matches. Awards in the F-Class will be made based upon the number of F-Class competitors in that Match. A cash prize will be awarded at the Awards Supper for the highest placed F-Class competitor, provided there are five (5) or more F-Class competitors entered. If there are two (2) or more F-Class teams entered in the Team Events, an F-Class Team award will be given.

**"AROS" – ANY RIFLE OPTICS SLING:** A cash prize will be awarded at the Awards Supper for the highest AROS competitor provided five (5) or more competitors are entered

**PIG ROAST:** A pig roast and Awards Ceremony will be held after the match on Friday, June 24, 2005. The cost for noncompetitors will be \$8.00; children under 12 \$5.00. Please **DO NOT** send in money with match entry fees. The money will be collected at the pig roast.
