Sunday, July 10th, The 200 & 300 Yard Stages of the Team Match. Check in from 7:15 to 8:15 AM.

Sunday, July 10th, 2005, The “Leg” Match will start after the Team Match (Approximately 11:00 AM) 50 Shot National Match Course (No Sighters).

Eligibility: Open to **any individual of the NRA** or a member of an affiliated Junior Rifle Club **and must be a member of WRPA or their home State Association.** Teams will consist of 4 members. An alternate, Non-firing Captain and coach may also be named, or the Captain or Coach may be firing members of the team. A team Captain Must be named (rule 12.1) Team Representation Club rule 2.11, Law Enforcement Agency rule 2.14, Service Rifle rule 2.13, State Assn Rule 2.12, or Junior rule 2.18. One member of the Team May be from an adjoining state.

RULES: NRA HIGH POWER RIFLE rules will govern

Course of fire (competitors will score and pull targets):

Stage1 200 yards Offhand 2 sighters, 20 shots for record in 22 Min. SR Target

Stage2 200 yards Sanding to sitting. 2 sighters, 2 strings of 10 shots in 60sec.

SR Target

Stage3 300 yards Standing to prone. 2 sighters, 2 strings of 10 shots in 70sec.

SR3 Target

Stage4 600 yards Prone. 2 sighters, 20 shots for record in 22 Min. MR-1 Target

Stage5 Rapid Fire aggregate Total of stages 2,3

Stage6 Slow Fire aggregate Total of stages 1,4

Stage7 Grand Aggregate Total of stages 1,2,3,4

Team Match: 50 Shot National Match Course with Sighters. Coaching is allowed.

“Leg Match” 50 Shot National Match Course. No Sighters. Coaching is not allowed.

CHALLENGES: A fee of \$2.00 will be charged for each challenge.

Location: The Racine County Line Rifle Club, Racine Wi.

Exit I-94 at 7-mile road. Proceed east on 7-mile road for approximately 6 miles. There is a Large sign at the range entrance directly after crossing the **3rd railroad crossing.**
